**I. Association Purpose**

- A. This organization's purpose is to conduct quality state tournament events for members as required by the United State Bowling Congress and to grow the Sport of Bowling through the conduction of those tournaments and other events.

**II. Charter**

- A. Charter Date
  - 1. The United State Bowling Congress chartered the Association on August 1, 2005 as Association number 85116.

**III. Tax Exemption**

- A. The Association is granted a Federal Tax exemption under the exemption granted to the United State Bowling Congress as a 501(C) 3 organization.
- B. There are no State Tax Exemptions.
- C. There are no Local Tax Exemptions.

**IV. Incorporation**

- A. The Association is incorporated in the State of Pennsylvania.

- A. IRS/Tax Information – the Association will file form 990 yearly with the Federal IRS.
- B. State Taxes – The Association will file employment taxes as required by Pennsylvania Law as follows:
  - 1. Unemployment Taxes
  - 2. Worker’s Compensation
  - 3. State Sales Tax as required.
- C. Full Financial Disclosure
  - 1. Audit – an audit will be performed yearly on the financial records of the Association.
  - 2. Financial Statements – current financial statements will be made available at each meeting of the board, state youth representatives meetings or by request of any board member.
  - 3. Budget – the board of directors shall approve an annual budget.
